1. Context

This Official Order is placed pursuant to and subject to the terms and conditions of Deed of Standing Offer **A201810-04** between the Commission and Macquarie University dated 1 November 2018.

The Australian Commission on Safety and Quality in Health Care (the Commission) is undertaking a project which will aim to:

- determine the prevalence and death rates of sepsis
- investigate variation in incidence and mortality rates related to:
 - Patient and hospital stay characteristics
 - Socioeconomic status and remoteness.

The data to be used in the analysis will include all patients admitted to all Australian hospitals from 2013-2018 and will be extracted using SAS from the Admitted Patient Care National Minimum Data Set (APC NMDS), specifically isolating the patients with a diagnosis of sepsis using ICD-10-AM codes. The classifications of sepsis will be scrutinised further as being primary or secondary, and severe (sepsis with vital organ dysfunction) or non-severe.

The report will assist the Commission in considering a way forward with our sepsis work.

2. Ordered Services

Macquarie University will be required to complete the following services:

- 1. Data extraction, cleaning and manipulation
 - a. Extract data from the APCNMDS
 - identify sepsis cases based on different definitions using ICD-10-AM codes
- 2. Data analysis taking into account the age-adjusted mortality rates, and the sepsis rates for all hospital admissions and for the Australian population. Patient demographic data, hospital stay information, type of wards, procedure codes, mode of separation and ICD-10-AM codes for organ dysfunction and other related comorbidities will also be utilised in the analysis. In addition, relative socio-economic status and remoteness will be examined.
- Draft Report providing epidemiological investigation and interpretation of variation in sepsis mortality and incidence rates, and will be provided to the Commission who will provide timely feedback for incorporation into the final report
- 4. **Final Report** providing epidemiological investigation and interpretation of variation in sepsis mortality and incidence rates, in accordance with the Commission's style guide.
- 5. Meeting with the Commission as required.

The specified personnel from Macquarie University will be required to work onsite at the Commission to complete the data extraction, cleaning and manipulation and the data analysis. The specified personnel will be provided with a secured building pass to the Commission's premises, a desk and IT access. In the event the Commission completes any or all of the data extraction, cleaning and manipulation deliverable, the fees relating to this service will be omitted or amended by the Macquarie University to correctly reflect actual work incurred.

3. Policies, Standards and Guidelines

The report will written in compliance with the Commission's Style Guide.

4. Required Contract Material

The requirement under the contractual agreement will be the submission of the draft and final reports that will provide the epidemiological investigation and interpretation of the variation in sepsis mortality and incidence rates, and will include all findings from the literature review and summary.
